

Vehicle licensing & insurance bulletin

New licence plate number configurations

ICBC will be gradually introducing new licence plate character configurations on some British Columbia licence plates. This will begin with the B.C. Parks - Porteau Cove series within the next few weeks, followed by regular passenger licence plates as early as August 2025.

What action do I need to take?

This bulletin is for awareness only. Within several weeks you may begin to see these legitimate new licence plate patterns on vehicles in traffic.

What are key facts for law enforcement?

No readability or misreading issues are expected because optical character recognition scanners do not rely on a fixed character sequence. All regular BC plates will remain six characters with the same design, reflectivity, and materials, making them scannable as usual.

The new licence plate patterns may include the letters 'U', 'Y' and 'Z', which were not previously used. The letters 'I', 'O' and 'Q' remain excluded from use because they present identification issues.

No updates are expected to be required to Automated Licence Plate Readers (ALPR) or backend systems (e.g., CPIC).

Will licence plates still have six characters maximum?

Yes. By altering the pattern of number and letter positions for each licence plate type, ICBC was able to increase available licence plate combinations using the same number of characters.

Why change formats?

The changes are necessary to ensure every licence plate has a unique alpha-numeric number, because the existing patterns are nearly used up.



Background

All BC licence plate types consist of no more than six characters. They follow unique patterns for the type of licence plate, type of vehicle and type of vehicle licence (e.g. farm truck.)

ICBC maintains approximately 40 licence plate types. New licence plate configurations will roll out as old inventories get exhausted from licence plates being issued with new vehicle licenses and from routine licence plate replacements.

To ensure there is sufficient inventory of unique licence plate numbers for the next twenty years, character pattern updates are planned for 16 licence plate types. Ten of these are scheduled for rollout as required over the next year.

Examples of new licence plate patterns

In the patterns below, # represents a number (0–9) and @ represents any letter (other than I, O, or Q.)
